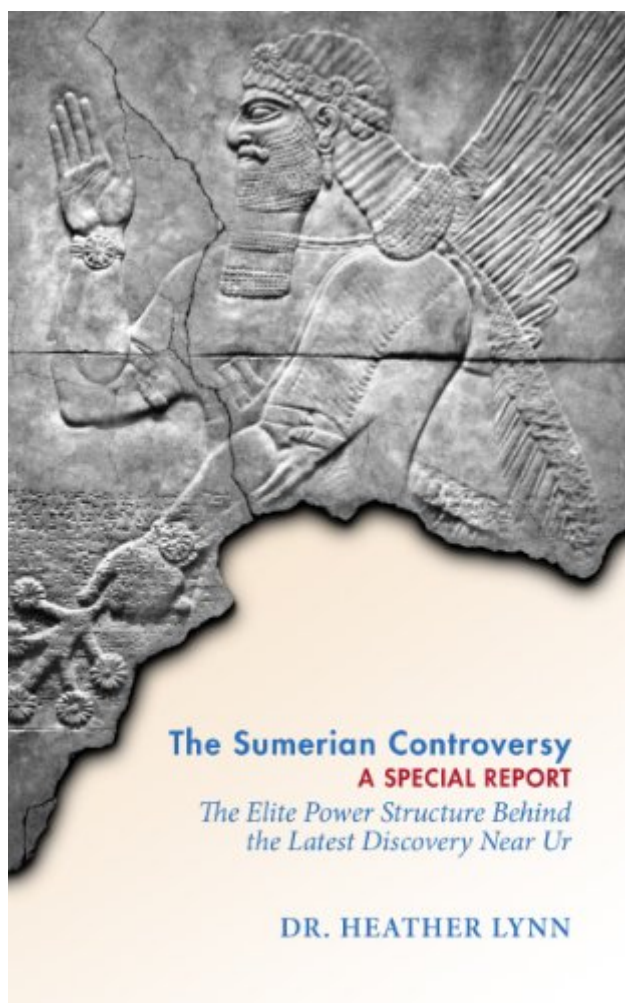

The key is in the title - Controversy and Report. As books go this is fairly short, hence the word Report in the title. The report deals with how the author found out about this new dig near Ur. How the author attempted to obtain information on this new site. And how the author ran into difficulties, was hindered, from obtaining information on this site. There is one page/paragraph about what was found or could have been found at this site. This book as well as others I have read seem to suggest that there are those in our society that would prefer to keep knowledge about our past to themselves. As another reviewer stated, it appears that this report is a lead up to the author's new book soon to be released - "Land of the Watchers." Once this book is available as an ebook I will be interested in reading it.

In The Sumerian Controversy, A Special Report - The Elite Power Structure Behind the Latest Discovery Near Ur, Dr. Heather Lynn writes that as she was researching material for this pamphlet (apprx 41 pages) she received anonymous, threatening and obscene emails to cease and desist. With the rise of ISIS, no one is claiming any benefit whatsoever from the US/UK invasion of Iraq and deposing of Saddam Hussein, who had the region's warring factions under control and was, he thought, America's ally. Dr Lynn writes of priceless treasures looted from Iraq by the British. In a very short portion, she mentions a rumor, authenticated by no means, that a Stargate has been discovered in the desert. I was perusing satellite images of Iraq, and stumbled onto the famous ziggurat of Ur. I followed a road connected to the area, and saw an arch through which the road passed, with some outlying buildings, out in the middle of nowhere. I don't know what it is, but it was interesting. I highly recommend Dr Lynn's booklet.

I had hoped to get more information about the discoveries. Dr. Heather Lynn is obviously frustrated with the elite establishment and the power of money. I totally understand. I even wonder why are there lately so many wars in that most ancient part of the world....could it be to "put sand" in our eyes by bombing the country and then restricting access to archeological sites, perhaps to conceal

specific evidence of that old civilization and its secrets? I don't know, just a thought.

This really is not a book- more like a long essay. It does complement LAND OF THE WATCHERS but should have been an addendum in that book and not being sold as a separate book. It wasn't worth the price + shipping for this.

Hopefully she will be able to pursue this inquiry but it appears that she has been stopped. A check to her website will indicate when and if she publishes new material. Since the religion of archaeology has a firm grasp in the U.S. anyone challenging that dogma is silenced or made irrelevant.

It was informative and interesting but unfortunately it was very brief and short.

Heather Lynn provides astonishingly important history and facts about history research. She also provides a valuable insight about the wrongful corporate backing of research. I recommend this book to all that read Sitchen's books, and in search of facts on ultra ancient history.

Looking forward to volume 2. Not enough information in this volume. It is written like an introduction. I think she could have waited for this book and included as a chapter in her next volume.
