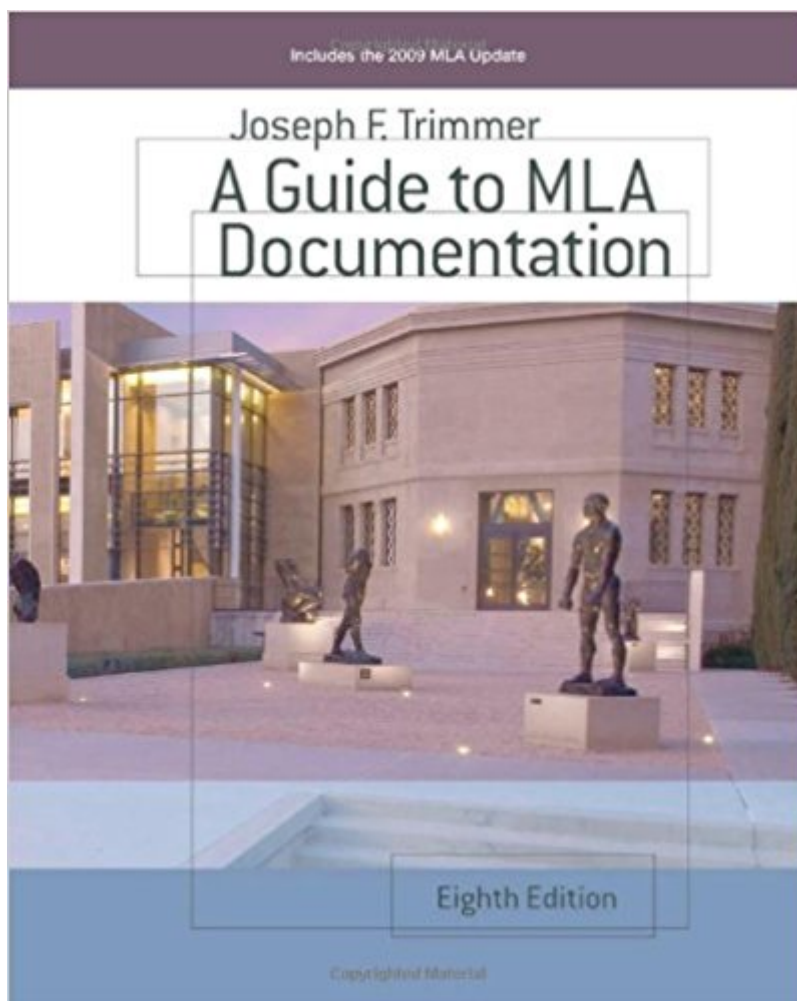

Joseph F. Trimmer is Professor of English Emeritus and Director Emeritus of The Virginia B. Ball Center for Creative Inquiry at Ball State University. He is the author of numerous articles on literature, culture, and literacy, including *THE NATIONAL BOOK AWARD FOR FICTION: THE FIRST TWENTY-FIVE YEARS* (1978), *UNDERSTANDING OTHERS: CULTURAL AND CROSS-CULTURAL STUDIES AND THE TEACHING OF LITERATURE* (1992), and *NARRATION AS KNOWLEDGE: TALES OF THE TEACHING LIFE* (1997). Professor Trimmer has also worked on 20 documentary films for PBS, including the six-part series, "Middletown" (1982). His textbooks include *WRITING WITH A PURPOSE*, 14th Edition (2004), *THE RIVER READER*, 12th Edition (formerly the *RIVERSIDE READER* (2016), and *eFICTIONS* (2002). Trimmer's *A GUIDE TO MLA DOCUMENTATION*, 9th Edition is a perennial bestseller; he has also published *A GUIDE TO APA DOCUMENTATION*.

I have been using the Trimmer edition of MLA since the first edition! I brought it with me to college,

and it got me through my entire undergraduate program. I have purchased many subsequent editions to try to keep up with some changes MLA has made. I also have purchased copies of the more comprehensive MLA guide, but for nearly all writing assignments, this edition has been sufficient - until now. This appears to be an example of lazy editing and of Mr. Trimmer and the people at Wadsworth Cengage Learning just wanting to cash in and make a buck. TWICE the sample essay at the end of the book has pages that are incorrectly numbered. If this were a student essay, I could forgive it, but this is a resource (an overpriced resource) and errors like that should not exist.

My English professor required this for my class. It's very thin, but helpful. However, all the information can be found online, making this purchase a bit unneeded.

This is a pamphlet rather than a book. It is soft covered and over-priced for what it is. Otherwise, it contains the typical information and examples of the currently acceptable methods for documenting sources cited in research papers and projects. Most of this same information is available for free on the internet, but maybe without the examples.

It seems to be very clear and useful for my 9th grader, but it is a 40 page booklet priced like a 200-page book. Quite a scam. I thought I had been sent the wrong publication (I can't call it a book).

Good book, for what I bought it for of course. I was attended Governor's School for the Arts and for some strange reason, they requested this book ;). It came in the mail pretty fast, the colors are a bit more brilliant than in the picture. It's not a sturdy thing, pretty flimsy, covers about 3X that of a magazine and the binding is just staples. Holds up, but wouldn't be too rough on it.

It is small and frail but the info is very informative! This book should be sold very cheap under 3.99 if not dont buy it

I was surprised at how expensive such a thin book with a soft cover could be. Difficult to understand why it would cost so much and frustrating that teachers and requiring children to buy it.

I had lost my MLA book on documentation and ordered one that I thought would be worthwhile. It might be worthwhile for a first year university student but it is not helpful for anyone else.
