

Still establishes the four tenets of osteopathy, which does not focus on musculoskeletal system. This should be renamed a medical law book. I have had a medical ethics class and this textbook mentions ethics that I have never even heard of as a healthcare profession. The authors also assert that medical schools require a four year degree while many do not. The reader will have to unlearn their incorrect facts and misinformation to later learn it the correct way.
