

There are more comprehensive (& expensive) books out there but if you have straightforward questions or just need to know where to start, this is all you need to get going.

Can't I give it zero stars? Pitifully incomplete guide on Social Security, and it says it's a guide on Medicare, but there couldn't have been more than a half dozen pages on that topic. Somehow in as short of a book as this is, it managed to be repetitive about certain things, yet miss major topics. It did not mention, for example, the strategy to employ if one spouse is non-working and the other spouse is working. There was not a word about file and suspend. I could have learned more on the Social Security web site. \$2.99 is \$3 more than it's worth. I read it in 15 minutes and then returned it for a refund.
