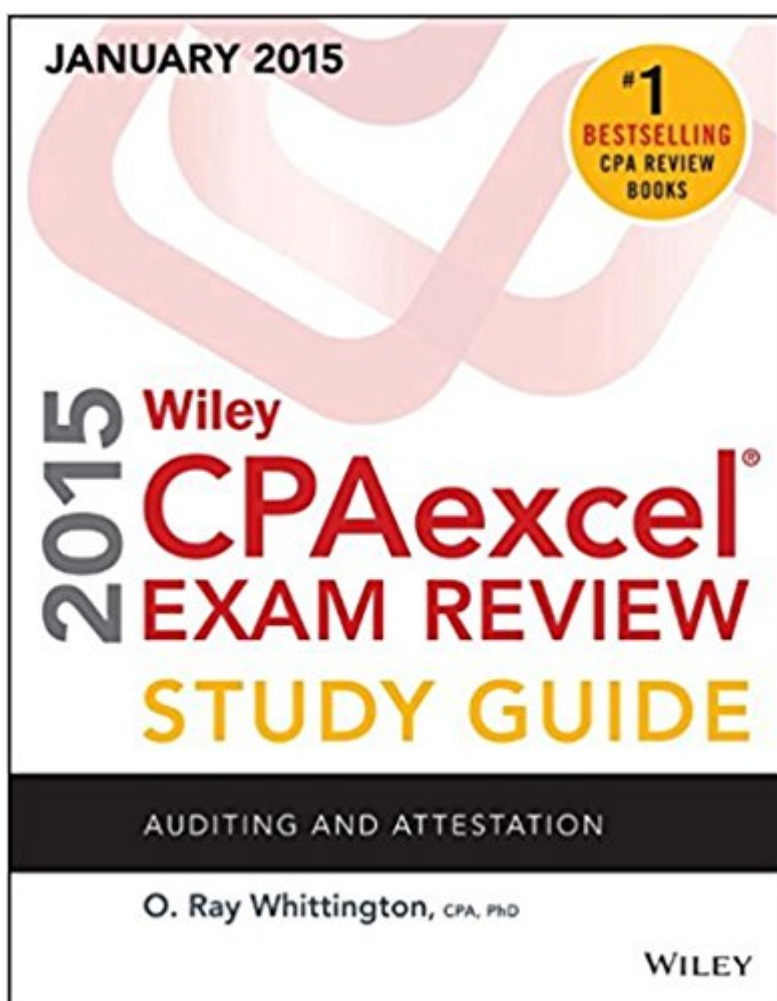

So, I bought this book as a supplement to my Becker review material. The Becker course that I have will be expiring soon and Wiley is so much cheaper. Overall, I would say it is a great course. I do have two major pet peeves. While the book gives you an explanation of why you got a multiple choice wrong, it can be very time consuming to find it in the chapter you just read. There have been a couple of multiple choice questions that I got wrong and, when I read the explanation for the wrong answer, I could not find where it was explained in the chapter or module that I had just read. This has only happened with a couple of the questions. It's not enough for me to say it's a bad review course, but it will cost Wiley at least one star. Secondly, you cannot practice the research simulations with the book. To me, this is a big deal since research simulations will be on the exam. They sort of teach you how to navigate through the AICPA standards, but the Becker material has all the AICPA standards built into the software so that you can practice searching through it. You WILL have at least one research question on the actual exam. I do not know if the Wiley software has the AICPA standards built into because I haven't bought it. I am pretty sure that it does. So I

wouldn't be too concerned with it if you are thinking of using Wiley. If you are looking for a cheaper alternative to Becker, Wiley will definitely suffice. It's not perfect, but none of the major review courses are. And you can't beat it for the price! Wiley will run you about \$240 per course section if you get the self-study pack offered on the website. Becker will cost you about \$1,100 per course! Really? \$1,100? Come on, Becker. I would recommend Wiley, but you will need to get the software so that you can practice the research questions. As a disclaimer, this is only my experience. I'm sure lots of people out there only bought the book and didn't have any trouble with the research questions on the actual exam. Experiences vary by person. Good luck with your studies.

The multiple choice questions don't have numbering. So if you are studying you have to count all questions to find out what the answers are. Horrible! Waste of time..

A great book

This review refers to the newly updated Kindle version (\$37 dollar one - not the older 9.99 one). I had to return this one. Kindle edition works great with the online reader, but on the android Kindle app (phone or tablet) there are issues: Multiple choice questions are missing numbers (such as question #1 vs #2 - so when you check your answers you will have to count all the questions to find your original question). Also, some of the diagrams get cut off!!! I tried landscape mode - and that did not solve the issue. Again, these issues are not seen in the on-line reader...but the on-line reader is not available from your cell phone. Sucks..now I have to carry the huge book around with me.

Passed this portion of the exam November 13th 2015 (85). I used this book as my primary study tool. Went through each chapter and took notes throughout the text. I actually just listed my copy for sale right now. I also used an online test bank and an audio CD but I think this book is what really did it.
