

This is one powerful book: it will grab you with vivid stories about individual kids, draw you in with honesty and compassion, and amaze you with alarming details about how the juvenile justice

system works (or rather, doesn't work) in America. Anyone interested in the problem of crime should read Edward Humes's gripping account of how future criminals are shaped in youth, and how the system misses its chance to help them before they're lost for good. As Richard Bernstein writes in the New York Times, "There are many admirable things about Mr. Humes's book, which, despite its grim subject matter, has a narrative power that keeps you reading right to the end. One of them is that Mr. Humes is a shrewd and perceptive observer of his young subjects ... [and he] allows himself to feel sympathy for the young people whose lives and crimes he describes.... After being granted access by court order to a system that is usually closed to the public, Pulitzer prize-winning journalist Humes (Buried Secrets) spent 1994 surveying the largely futile attempts of Los Angeles to deal with its juvenile crime. He concentrates here on a few who have not let themselves be overwhelmed by the deluge of defendants-80,000 cases are pending at any given time: Judge Roosevelt Dorn, who is also a clergyman; Deputy DA Peggy Beckstrand, who finally leaves the system to work on adult cases; Probation Officer Sharon Stegall, who tries to cope with the insurmountable burden of supervising 200 juveniles; Shery Gold, a public defender who also wants to move to adult courts. Humes follows closely the cases of seven young people who were caught up in the system, three of whom have been saved by it?maybe. First serial to Glamour and L.A. Magazine.
